Course Title: Post-Secondary Options Counseling for Potentially Eligible Participants

Duration: 8 units per customer (4 hours total), delivered in 30-minute sessions

Course Overview:

Course Objectives:

Session Breakdown:

Session 1: Initial Engagement and Assessment

- **Duration:** 1 unit (30 minutes)

 - o Tools and templates for effective planning and task management
- Outcome: Personalized skill-building plan for academic and vocational success.
